FORFEIT & WITHDRAWAL	Each NF is responsible for informing immediately both the AVC and Organizers in case of forfeit of an enrolled team. Such withdrawal shall be sent to AVC and organizer at least 3 days before the tournament starts. In case of urgency, verbal communication to either AVC or its official on-site will be accepted.	
AVC OFFICIALS	<ul> <li>AVC will appoint 2 AVC officials (1 Technical Delegate, 1 Referee Delegate) and 3-4 Neutral Referees.</li> <li>The organizer will be responsible for AVC officials and neutral referess per diem, round-trip air ticket, full board and lodging, local transportation, and COVID-19 test expenses (if required)</li> </ul>	
SEEDING	Seeding and Entry Regulations and Withdrawal: in accordance with the decisions of the AVC Beach Volleyball Committee.	
COACHING	Coaches must be approved by the AVC Delegate and desirably be accredited by the AVC as a minimum.	
ANTI-DOPING	AVC reserves the right to perform random anti-doping controls, as per

INSURANCE	It is mandatory that all athletes and officials have their own liability and medical insurance. The AVC and the Organizer will not be held responsible for any medical expenses incurred while competing in the tournament.	
BOARD & LODGING	<ul> <li>For players, the organizer will be responsible for full board and lodging at the Competition Hotel from the official arrival day until the day after their be eliminated.</li> <li>Team officials and extra team members and the players after their elimination, have to be responsible for the expenses as follows: <ul> <li>US\$100/day/person for twin shared room and US\$130/day/person for single room (three meals and Local transportation are included)</li> <li>All participants are however personally responsible for all and any extras at the hotel such as mini bar, phone calls, laundry, etc. that must be paid at checkout.</li> </ul> </li> </ul>
