## **3. Competition**

### Team registration

IMPORTANT: Otherwise, the teams will not be eligible to participate in the event. If the federations have any problems in register teams in VIS system, please contact AVC Beach Department for further assistance.

### Player's eligibility

- Only players, who have sent to the AVC and the organizer the required forms, and register in the VIS system will be considered eligible to take part in this event.

### Competition format

- Main Draw 24 teams with pool play followed by a single elimination tournament (Round of 16, QF, SF, and Finals)

### Country entry numbers

- Maximum 2 teams per gender each National Federation.  
Only host National Federation can enter a maximum of 3 teams.
- In case the Main Draw is not full (less than 24 teams), the reserve team from Host and the reserve team(s) with the most entry points as of -35 days among all participating NFs' reserve teams will be selected to fill the Main Draw.

### Entry & Seeding points

- The combined finishes (points) of all two players becomes the team ranking/seeding. Calculated by:
  - Each individual player's best finishes, in terms of ranking points, in FIVB sanctioned events within the last 365 days up to the day of General Technical Meeting. Maximum of 4 events.
  - Plus Each individual player's best finishes, in terms of ranking points, in AVC sanctioned events including Multi-sport and zonal/ regional events within the last 365 days up to the day of General Technical Meeting. Maximum of 4 events.
  - Only 1 Multi sport or Zonal / Regional event to be included in total.
  - Only 1 AVC Championship event to be included in total.

### Forfeit & Withdrawal

- Each NF is responsible for informing immediately both the AVC and organizers in case of forfeit of an enrolled team. Such withdrawal shall be sent to AVC and organizer at least 3 days before the tournament starts. In case of urgency, verbal communication to either AVC or its official on-site will be accepted.

### Training

- Please note that official training starts as **16 July 2025**.
- Training session reservations can be made no more than 24 hours in advance.
- Each team is entitled to make one reservation per day (i.e. teams cannot reserve multiple training sessions for the week ahead).
- Additional training sessions may be possible only if the courts are available.
- Athletes must register in the training booking platform at least 24 hours before the intended training session.

#### Mixed Zones and Press Conferences

#### 4. Accommodation & others

##### Accommodation

- The host organizer will cover for the full board and lodging for Main Draw players (**twin bedrooms**) from the official arrival day until breakfast on the day after elimination.
- **The host organizer will not cover for the full board and lodging of reserve teams/extra players who are not in the Main Draw.**
- All participants will be personally responsible for all extras at the hotel such as mini-bar, phone calls, etc. including any damage incurred to the room. Payments must be made upon checkout.
- **After the preliminary round, teams that do not qualify must return to their home country the next day. Likewise, teams eliminated after the quarter-finals are required to return home following the conclusion of the quarter-final matches.**

- The rate of full board and lodging for extra members:

##### Accompanying referees

- One accompanying referee MAY be nominated by NFs entering 2 teams in AVC Beach Tour.
- The host organizer should support accommodation and per diem for the accompanying referees from participating NFs if any, same rate as local referees.
- The names of accompanying referees should be approved by AVC in advance.
- The maximum number of accompanying referees is agreed by the organizer in advance.

##### Transportation

- The official airport confirmed by the organizer is as follows:

- Players and team officials have to be responsible for the domestic flight vice versa (if any).

##### Accreditation

- Accreditation will be required by all athletes, coaches and team officials, AVC officials, referees, VIPs, media, technical staff, court personnel, volunteers, vendors, etc. by organizers, and will ensure that only those with appropriate accreditation can access the designated venue areas.

#### Catering

- The organizer will provide all three meals for Main Draw players from the official arrival day until breakfast of the day after the team was eliminated from the event.
- The organizer will provide all three meals for referees, and AVC officials being breakfast, lunch and dinner at the official hotel from the official arrival day until breakfast of the official departure day.

#### Medical Services and procedures

- During Competition & Training
  - During Competition & Training, there will be a first responders with an ambulance will be on standby at the venue.
  - AVC reserves the right to perform random anti-doping controls, as per FIVB rules and regulations.
- Out of Competition & Training
  - For Out of Competition & Training there will be the option to arrange a first aid treatment in the hotel. If more treatment is necessary, local organizer will provide transportation where needed.
